Jon Leonard and Robb Barnitt of TIAX, Inc., presented a status report on the Gateway Cities Clean Air Program, and reported that the COG was nearing the \$1 million mark in incentive grant awards.

President Colonna presented a brief status report on the Rivers and Mountains Conservancy. It was moved by Member Andrews, seconded by Member Putnam, to receive and file the report. The motion was approved unanimously.

The Executive Director reported that the City of Carson and the Port of Los Angeles had approved implementation agreements to join the I-710 Oversight Policy Committee and that the County of Los Angeles was expected to approve an agreement later this month. He said that the project consultant would be presenting status reports on the Major Corridor Study to the I-710 Technical Advisory Committee and the I-710 Oversight Policy Committee on the 22<sup>nd</sup> and 23<sup>rd</sup> of this month. It was moved by Member Putnam, seconded by Member Lowenthal, to receive and file the report. The motion was approved unanimously.

Member Proo reported that there had been no meeting of the Transportation Committee this month. She presented a brief update on the MTA service sectors and said that applications were now being taken for the Gateway Cities Service Sector Committee. She announced that a follow-up conference to Mobility 21 would be held on January 21, and that the deadline for the MTA Call for Projects had been extended to March 28. It was moved by Member Barrows, seconded by Member Lowenthal, to receive and file the report. The motion was approved unanimously.

There were no reports from the SCAG Regional Council.

There were no reports from SCAG Policy Committee members.

Member Barrows requested that an item be agendized for next month's meeting regarding the COG's membership on the Orange Line Joint Powers Authority.

There were no additional items from the staff.

It was the consensus of the Executive Committee to adjourn the meeting.
